For this reasons a lot of entity are specialized in evaluation and accreditation of the courses.

So, if you decide to elaborate a course for long distance, eLearning, for vocational training or other forms of learning based more or less on electronic development, maybe is better to thing about certification of your course.

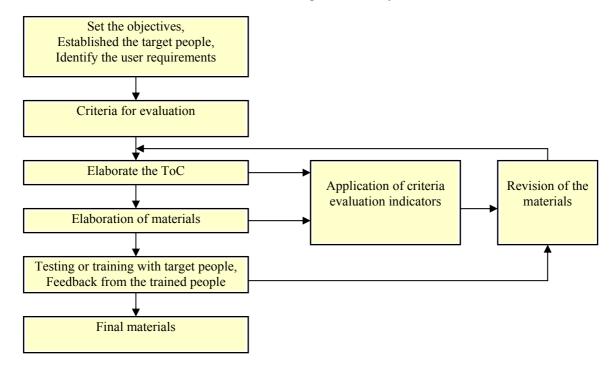

# 2. Criteria for evaluation of courseware quality

Evaluation of courses is an important process and a complex one. For this evaluation you can use a specific criteria made by an independent entity or a comprehensive criteria from different bodies.

#### The **main steps for assuring the quality** of the courses are:

- ☐ Set the objectives of the courses
- ☐ Established the target people
- ☐ Identify the user requirements
- Elaborate the table of contents for the entirely courses
- ☐ Established criteria for evaluation
- ☐ Elaboration of respective materials
- Application of the evaluation criteria
- Testing or training with the materials elaborated on group of persons
- Evaluate the results based on feedback of the trained persons
- ☐ Final revision of the elaborated material according with the study of evaluation results



## 2.1. General criteria for entirely course

On evaluation process you can use various criteria and one of them is regarding the general overview of the courseware. The next table of elements shows the most important aspects that must be accomplished by the course. Complete this table according with the corresponding situation of your material.

Also, for the process of elaboration of the content on your courses is good to monitoring and evaluating continuously. Some useful criteria are presented on the following table. Total score obtained after evaluation is on your appreciation, but a good example would be: from 0 to 6 points = very poor course; 7 to 18 = poor course; 19 to 30 a normal course; 31 to 42 a good course; and from 43 to 48 a excellent course.

# 3.2. Evaluation of the results for the trained people

We see that the feedback is important at the end of the course for small adjustments for the next one.

If your course is taking for more months or even years, is recommended to maintain a feedback with the people after finishing the course.

The main questions that can be interesting are:

- Did you work into a field of internet occupations jobs
- ☐ How the courses influenced the activity developed after the ending of the courses

Uhat are the jobs that you can reach with the knowledge from the course?

This information could help you to decide what changes are necessary, to maintain a high level knowledge.

## **Key Point Summary Conclusions and Recommendations**

- 1. Own evaluation of your elaborated materials or an independent evaluation from a well known entity is very important for the quality.
- 2. Assuring the quality for a product, in fact, guarantee the client, on long term.
